An individually small amount, donated monthly, will make a tremendous gift over time to support the ministry and programs of our camp.

Q. How does AFT (Automatic Funds Transfer) work?

A. With your permission, funds are automatically transferred from your chequing or savings account to Katepwa Lake Camp. This takes the place of writing a cheque.

Q. Do I have a record that the automatic payment has been made?

Your monthly bank statement will show the transfer has been made to KLC on either the 1st or the 15th of each month, depending on your preference (*the following business day should this be a non-banking day*). Your bank statement will include the date and amount of the transfer.

Q. Is my gift tax -deductible?

A. All gifts to KLC are tax-deductible, and the Camp will issue a tax deductible receipt on an **annual** basis for donations received.

Q. How do I adjust or stop automatic payments?

A. You can adjust the amount of the payment by notifying KLC in writing. Should you wish to discontinue for any reason, you can do so by writing or via phone. Please allow 15 business days for processing.

Q. How do I get my transit/Bank number?

A. This information is included in the numbers on the bottom of your cheques. Please attach a voided cheque to this completed form and we will do the rest.

Q. Is there a minimum gift?

R. *Any gift to the Camp is appreciated and makes a difference. Even \$5 a month would be helpful!*

2. Enclose a voided cheque with your this form.
3. Mail this form with your voided cheque to Katepwa Lake Camp at the address below.
4. Be sure to notify KLC when you change banks, move, wish to change donation amounts, or discontinue the Automatic Funds Transfer. **You can contact our office at 306-525-2256.**
5. Once this gift transaction is processed, you will receive a written acknowledgement and thank you from KLC on an annual basis.
